1. Schengen Visa Services

- Service Fee: 80,000 KES (Reduced from 150,000 KES)
- Includes: Consultation, document preparation, application submission, and embassy appointment scheduling.
- Additional Services:

- One-time reapplication support in case of visa denial (limited to one reapplication)
- Maximum of 3 coaching sessions (each 20 minutes)

2. U.S. Visa Services NIV

- Service Fee: 70,000 KES (Reduced from 130,000 KES)
- Includes: Consultation, document review, DS-160 form submission, visa interview coaching, and embassy appointment scheduling.
- Additional Services:
 - One-time reapplication support if denied
 - Maximum of 3 coaching sessions (each 20 minutes)

3. Canadian Visa Services (Tourist, Business, Sabbatical Leave Student)

- Service Fee: 110,000 KES (Reduced from 180,000 KES)
